#### SES Moratorium Lifted

The moratorium on SES **Executive Core Qualifications** (ECQ) processing has been lifted by HHS and OPM! These moratoriums are put in place by OPM to ensure full opportunity for a new agency head to exercise his or her prerogative to make or approve executive resources decisions that will impact the agency's performance during his or her tenure. There is currently a 6-8 week lead time on SES ECQ reviews with OPM's Quality Review Boards.
